**In the matter of Lt. Col. Asim Mehboob (52263-P) received from the Medical
Directorate, GHQ, Rawalpindi**

The Pakistan Medical and Dental Council received referral from the Medical Directorate of the General Head Quarters, Rawalpindi against Lt. Col. Dr. Asim Mehboob (52263-P). It was conveyed to this Council that Lt. Col. Dr. Asim Mehboob proceeded to Saudi Arabia to perform Umrah and to the UAE for tourism, on ex Pakistan leave from 19 May 2024 to 02 June 2024. He did not report back to duty after the expiry of the above-said ex-Pakistan leave and absented himself from duty from 03 June 2024. By absenting from active military service, Lt. Col. Dr. Asim Mehboob has violated the law and become fugitive, bringing bad repute to the institute. Accordingly, the PM&DC is requested to suspend the PM&DC registration, Faculty registration and Good standing of the Respondent.

FINDINGS:

The Disciplinary Committee notes that the conduct of the delinquent Dr. Asim Mehboob, a serving officer of the armed forces of Pakistan, prima facie, falls short of the medical standards. Accordingly, it is recommended that the medical registration / license of Lt. Col. Dr. Asim Mehboob (52263-P) be suspended. Furthermore, it is recommended that the good standing certificate of Lt. Col. Dr. Asim Mehboob (52263-P) be also revoked, till he is tried under the law.



In the matter of ex-Dr. M. Umair Ashraf (36601-1186781-7) received from the Medical Directorate, GHQ, Rawalpindi

The Pakistan Medical and Dental Council received referral from the Medical Directorate of the General Headquarters, Rawalpindi against ex-Dr. Umair Ashraf (36601-1186781-7). It is conveyed to this Council that ex Doctor Muhammad Umair Ashraf s/o Muhammad Ashraf Shad (NIC # 36601-1186781-7) served in Army Medical Corps until his dismissal from service on 14 Jan 2022 due to his involvement in cases of moral turpitude. Accordingly, the PM&DC was requested that permanent registration of the aforementioned ex-army officer may kindly be terminated / revoked.

FINDINGS:

The Disciplinary Committee notes that the conduct of the delinquent ex-Dr. Umair Ashraf, a former member of the Army Medical Corps (later dismissed from service due to involvement in cases of moral turpitude), prima facie, falls short of the medical standards. Accordingly, it is recommended that the medical registration / license of Dr. Muhammad Umair Ashraf s/o Mr. Muhammad Ashraf Shad (CNIC: 36601-1186781-7) be suspended.
