TUITION FEE-NOTIFICATION

In pursuance of the recommendations of the Committee on Medical Education constituted by the Hon'ble Prime Minister of Pakistan, in its meetings held on 27th March, 2025 and 18th December, 2025, and in exercise of the powers conferred under Section 20 (7) & (8) of the Pakistan Medical & Dental Council Act, 2022, the Council, after due deliberation, has considered the requests of private medical and dental institutions for enhancement of their tuition fees.

2. Upon careful examination of the recommendations of the Fee Justification Committee and scrutiny of the audited financial statements submitted by the respective institutions, the Council has unanimously resolved to approve the following tuition fee caps, as specified against each institution:
